The MCC East Bay will provide financial assistance to Muslims in the San Francisco Bay Area in need of assistance to meet funeral expenses.

Applicants must qualify financially, because either the decedent leaves no funds to cover his or her final expenses or family members are financially unable to provide for such expenses. The assets and resources of the deceased and the applicant are considered when determining eligibility.

In most cases, a family member should apply for the deceased. An application is processed only after death occurs. Family members may apply in advance only if a medical doctor deems that death is imminent.

After submitting this application, applicants will come in for an appointment with Burial Administrator Aminah Abdullah. An appointment is mostly scheduled the same day. Eligibility is usually determined within 24 hours.

The MCC uses its dedicated Burial Fund and, at its discretion, use its Sadaqah funds to cover final expenses.
